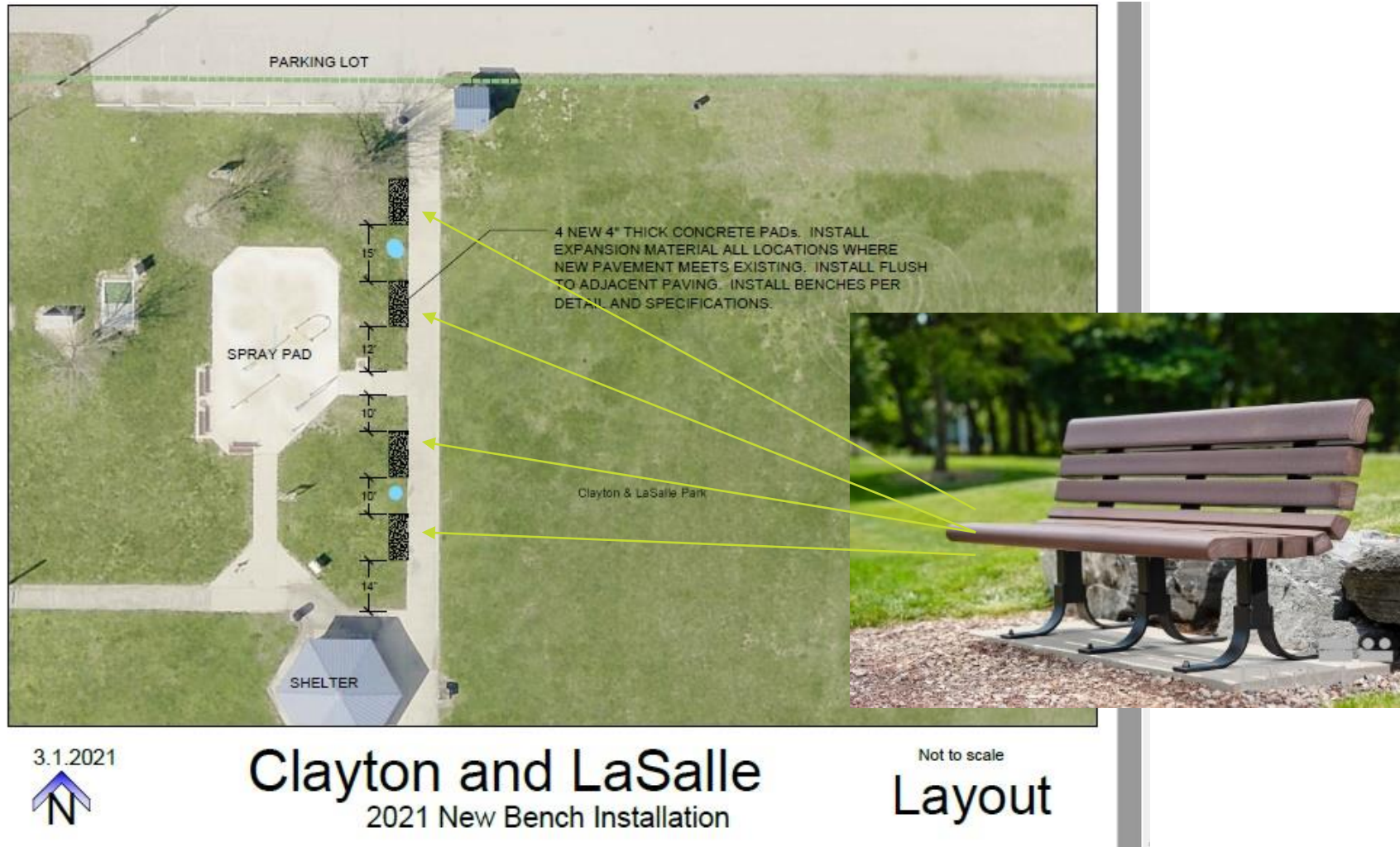

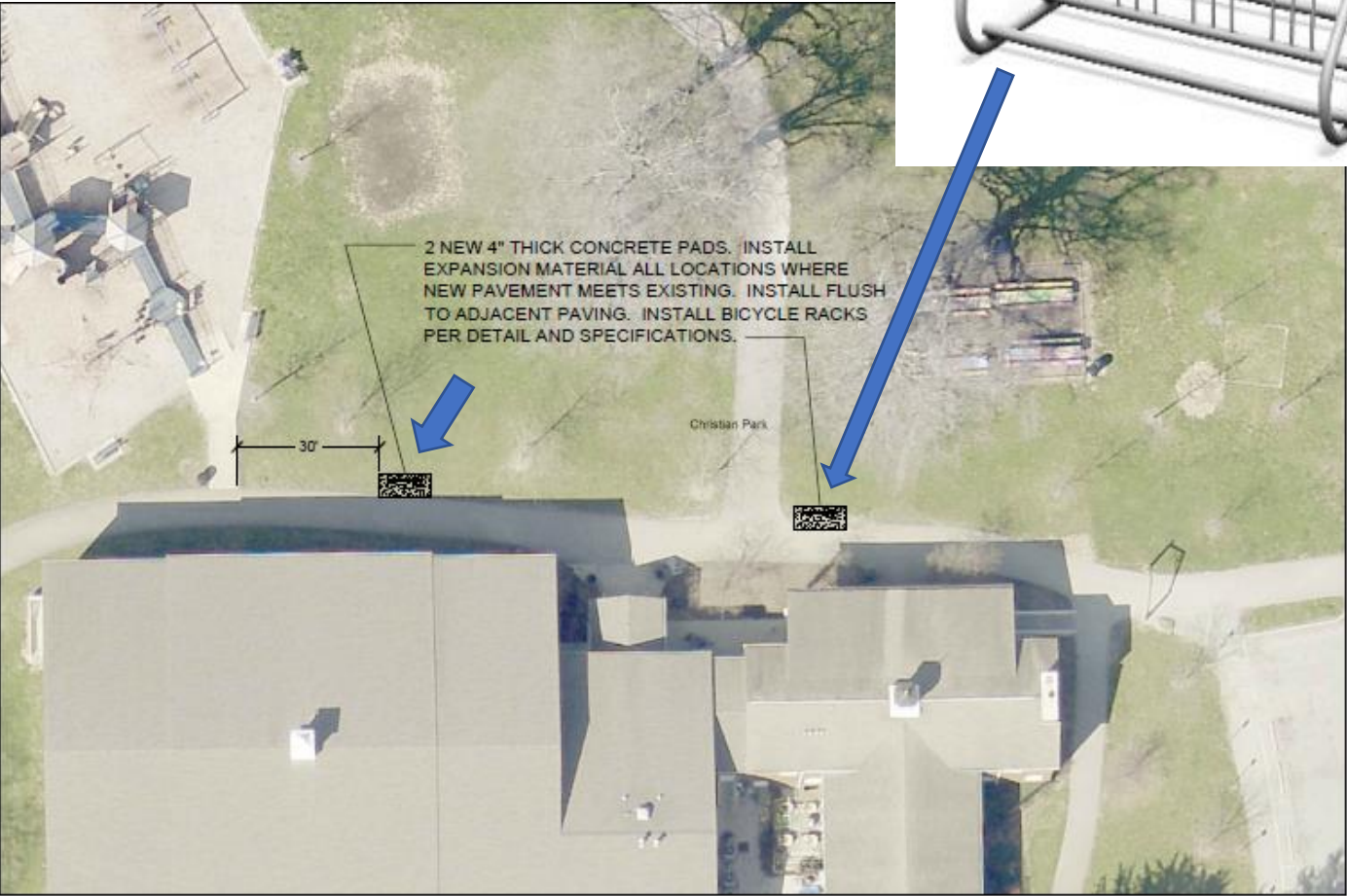

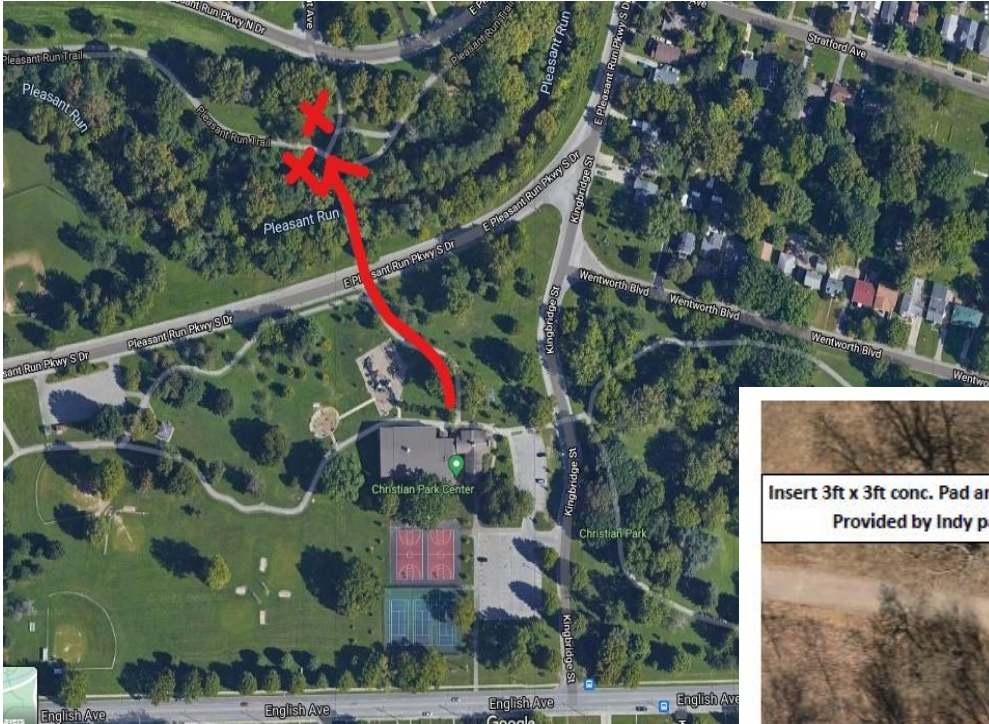

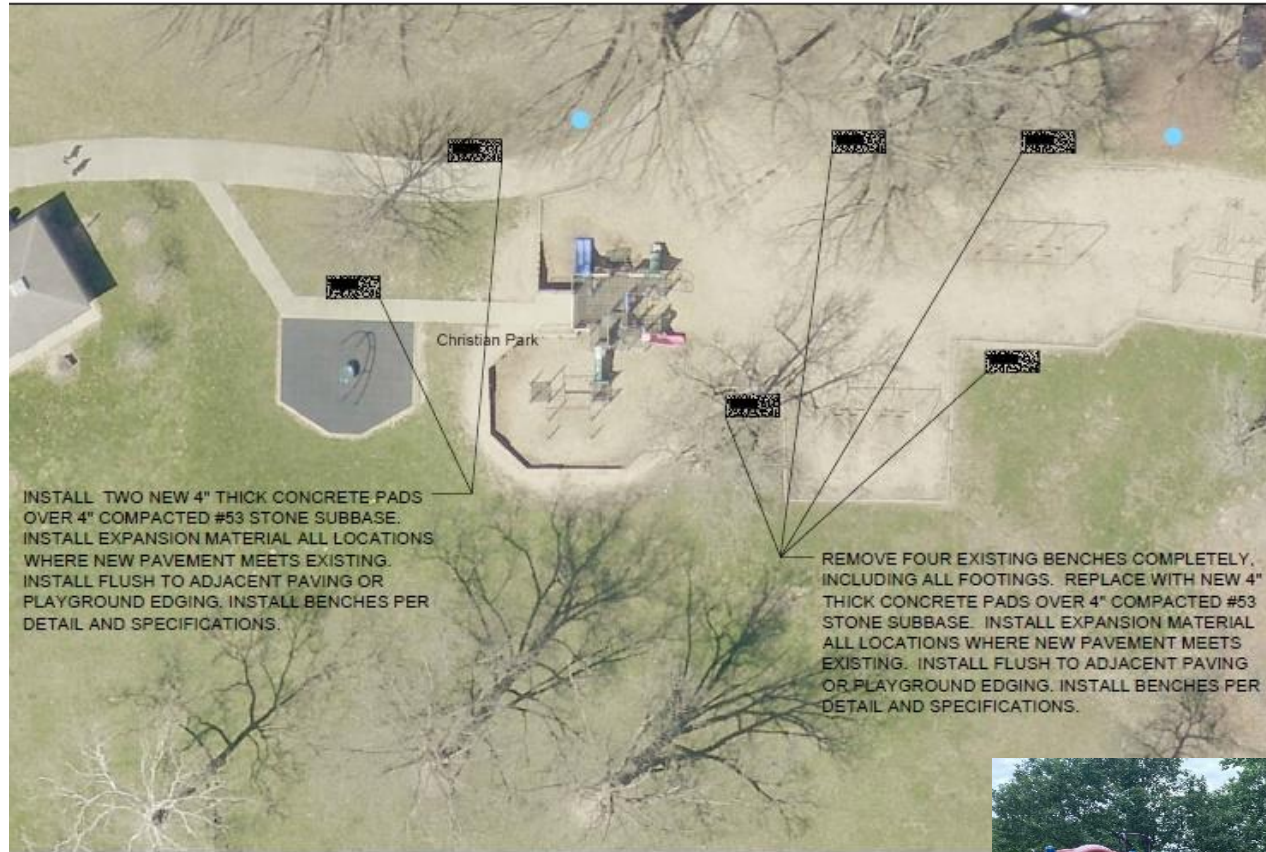
CHRISTIAN PARK/PLEASANT RUN TRAIL BRIDGE

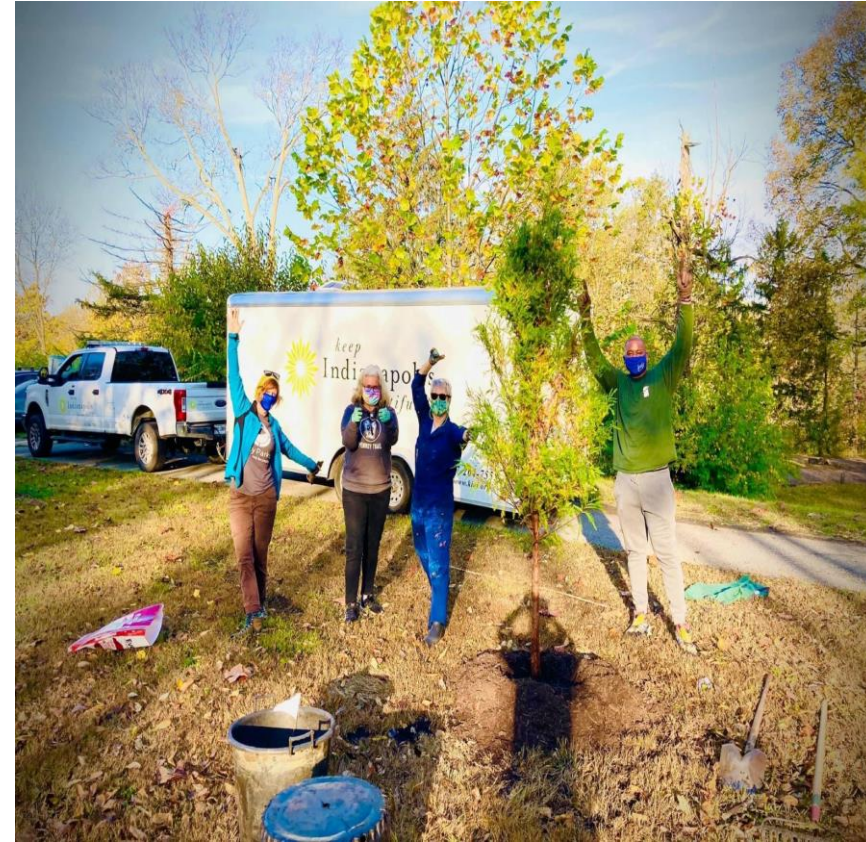
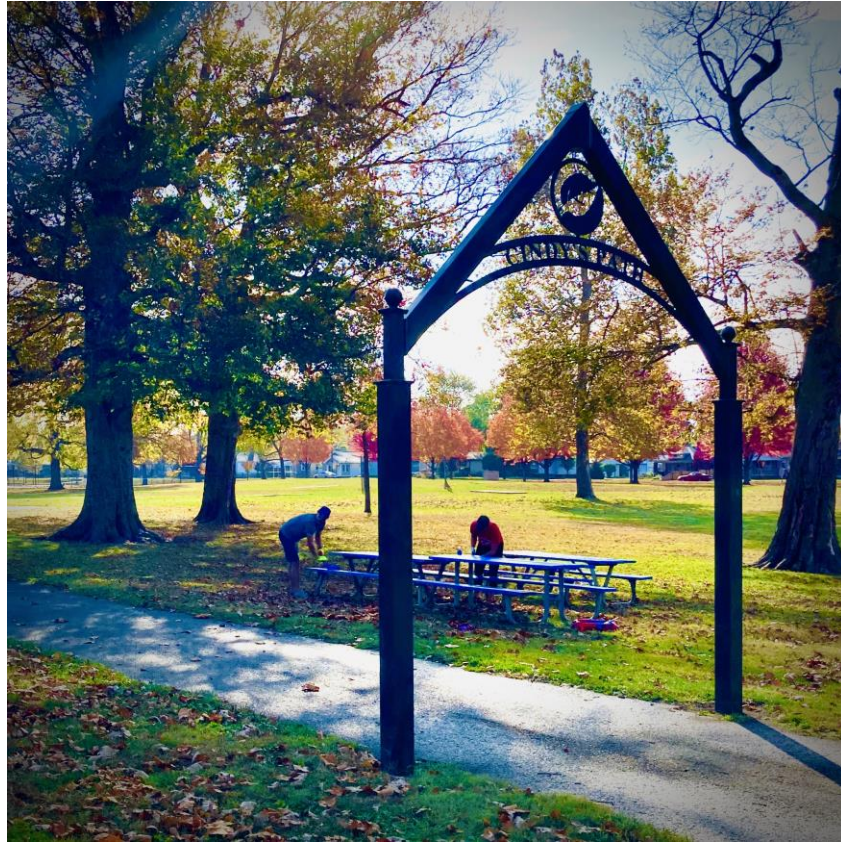
